## **FACILITY USE AGREEMENT**

This Facility Use Agreement ("Agreement") is made between Youth Baseball Association, LLC ("Owner") and the undersigned user ("User") for the use of the batting cage and equipment located at 261 Niagara Carthage Road, Carthage, NC 28327.

By signing this Agreement, the User acknowledges and agrees to the following terms and conditions:

#### 1. Use of Facility and Equipment

# 7. Waiver of Liability

- 7.1. The Owner is not responsible for any injuries or accidents that occur while the facility is in use.
- 7.2. The User assumes all risks associated with the use of the facility and agrees to hold the Owner harmless from any claims or liabilities arising out of their use.

# 8. Scheduling

- 8.1. The User agrees to adhere to the scheduled time slot allocated to them.
- 8.2. Any changes to the schedule must be approved by the Owner in advance.

#### 9. Termination of Use

The Owner reserves the right to terminate this Agreement at any time for violation of these terms or for other reasonable cause.
